Joe G reported the same inventory / cash situation as last month. He suggested holding off on any literature ordering for now.

Bridget V and Joe will continue working on ordering details, including a form to present to individual groups. It was noted that the signature of a co-chair is required to complete the process. When ready, the form will be sent to individual groups and onto the website.

Matt M noted that individual groups can still order directly from WSO, although ordering through RI ACA Intergroup should still be encouraged.

**Agenda item #2: Treasurer's report:**

Matt M reported there is currently \$732.27 in the Intergroup treasury plus \$100 pending for a total of \$832.37. Subtracting \$400 prudent reserve leaves \$332.37 available.

He stated the yearly Zoom channel fee of \$150 will be paid this month.

He stated a breakdown of all distributions will be made available.

Motion made and unanimously carried to send \$200 to WSO for support.

Motion made and unanimously carried to accept Treasurer's report.

**Agenda Item #3: Website / Technical report**

The Women's yellow book work group on Sundays will be ending.

There are plans to offer recovery oriented movies as community outreach to any and all in ACA. Deana and Bridget B will be coordinating. More details are forthcoming.

Motion made and unanimously carried to accept Website / technical report.

**Old business:**

Matt M suggested outreach to individual groups for electing RI ACA Intergroup representatives continue as a priority. Not all groups are represented currently.

It was noted that electing and rotating service positions are important for continuity and structure in Intergroup.

The newsletter committee is formed, and has met once so far. There will be more information forthcoming.

It was noted that individual ACA members can monitor any national or regional groups informally.

Motion made and unanimously carried to postpone service elections to local, regional, and national service positions.
